EXECUTIVE SUMMARY

What we found

Of the \$24,780.00 billed across this matter, \$3,420.00 (13.8%) consists of charges that are commonly questioned, commonly disallowed, or fall outside the reasonable range under Texas Disciplinary Rule 1.04(b) when compared against the engagement letter and prevailing Travis County market rates.

Our analysis flagged 14 line items across four recurring patterns: block billing, billing administrative tasks at attorney rate, full-rate travel, and one likely double-billed entry. None of these findings, on their own, constitute a fee dispute, but together they give you a clear, citation-backed basis to request itemization or a partial fee adjustment.

TOP FINDINGS

The four patterns driving the flagged amount

FINDING 01**Block billing across research / draft / review**

Six entries combine multiple tasks into a single time block (e.g. "research, draft, review" billed as 6.0 hr). Texas fee-arbitration panels routinely require itemization for any block-billed entry exceeding 2 hours. Recommend requesting a re-itemized invoice for these six entries before paying.

FINDING 02**Travel billed at full partner rate**

4.2 hours of travel time (Austin → Houston deposition) was billed at the full \$750/hr partner rate. Industry guidelines and the Texas Code of Professional Responsibility Comment 1.04 treat non-working travel as billable at half rate or as a flat travel fee. Excess at issue: \$1,575.00.

FINDING 03**Administrative tasks at attorney rate****\$262.50**

Three entries totaling 1.4 hours describe scheduling correspondence, calendar management, and file organization, work most fee guidelines treat as paralegal-rate or non-billable overhead. Suggested adjustment based on Travis County paralegal rate (\$175/hr) vs partner rate billed: \$0-\$87.50 per entry.

FINDING 04**Likely double-billed correspondence review****\$300.00**

commonly disallowed

Entry on 10/03 ('review correspondence, 0.4 hr, \$300') appears to cover the same documents as entry on 10/04 ('review correspondence and prepare response, 0.7 hr'). Same recipient, same case reference, no new documents identified between entries.

Categories defined: **Consistent**, within fee-guideline norms. **Commonly questioned**, fee-arbitration panels frequently reduce or require itemization. **Commonly disallowed**, typically reduced or removed under Texas Disciplinary Rule 1.04 or comparable state-bar guidance.

TALKING POINTS

Questions you may want to ask your firm

On block billing	"I noticed several entries combine research, drafting, and review into single time blocks, for example the 10/10 entry billed at 6.0 hours. Could you provide an itemized breakdown for those entries? Texas fee-arbitration panels typically require this for any block-billed entry over 2 hours."
On travel time	"The deposition travel on 10/06 was billed at the full \$750 partner rate for 4.2 hours. ABA Formal Opinion 93-379 and most state guidelines treat non-working travel at half rate or a flat fee. Could we revise that to either half rate or a fixed travel fee?"
On administrative tasks	"Three entries describe scheduling, calendaring, and file coordination. Could those be re-billed at your paralegal rate, or written off as overhead? That's consistent with ABA Op. 93-379 and Missouri v. Jenkins."
On the duplicate review	"The 10/03 and 10/04 entries appear to cover the same correspondence thread. Could you confirm whether the 10/03 entry covered different documents, or remove it from the invoice?"

OPTIONS YOU MAY WANT TO CONSIDER

Three paths forward

These are common paths Texas clients take when bills look like this. None of them is legal advice, and which one fits depends on your relationship with your firm, the size of the issue, and your comfort level. Most clients start at option 1 and only escalate if the firm is unresponsive.

Request itemization first

Send the firm a brief written request for: (a) re-itemized entries for any block-billed line over 2 hours, (b) confirmation of which paralegal vs attorney work was billed at which rate, and (c) clarification on the 10/03 / 10/04 correspondence entries. Most billing concerns resolve at this step. Firms have a professional obligation under Tex. Disc. R. 1.04(b) to provide this information.

Texas State Bar fee dispute resolution

Texas runs a free, voluntary fee-arbitration program through the State Bar's Client-Attorney Assistance Program (CAAP). It's non-adversarial, confidential, and binding only if both parties agree. Median time to resolution: 60–90 days. Bring this report and the engagement letter.

How this report was generated
